4. Import XBRL file

1. Now you can import and view previously generated XBRL files by clicking Import XBR information sheet.

5. Steps for Filing Shareholding Pattern

- I. Fill up the data: Navigate to each field of every section in the sheet to provide appl format. (Formats will get reflected while filling data.)
 - Use paste special command to paste data from other sheet.
- II. Validating Sheets: Click on the "Validate" button to ensure that the sheet has been $\mathfrak p$ data has been furnished in proper format. If there are some errors on the sheet, excel $\mathfrak p$ about the same.


